

PARTICIPATION REQUIREMENTS:

- **1.** All relevant indigenous art must be in compliance with the Indian Arts Native American & Crafts Act of 1990.
- **2.** Provide 3 samples in each category for jurying purposes.
- **3.** If accepted into the Market, artists will be required to be re-juried every 4 years to ensure the quality and consistency of their product(s).
- **4.** All work submitted must be original and handcrafted by the Artist.
- **5.** All products sold must have the Artist's signature or initials.
- **6.** Artists will display only work in the category in which they are accepted into the Market. Bellas Artes reserves the right to monitor booths to assure compliance and/or violation of Market guidelines.
- 7. The Market is family-oriented, therefore explicit artwork is not acceptable.
- **8.** Accepted Artist and Collaborators must be present in booth at all times.
- **9.** Artists must have their booths set up by 9:30 am on the first day of the Market.
- 10. Artists are responsible for collecting and reporting appropriate New Mexico Gross Receipts tax.
- 11. Sales are not allowed before or after the assigned Market times and days.
- 12. Artist displays may not exceed assigned booth space; no items allowed outside the booth space.
- 13. No alcoholic beverages are allowed on the premises.
- **14.** Amplified music is not allowed inside booth areas.
- 15. No displays of previous artist awards or other types of awards are allowed in Artist booth.

SECURITY: Overnight security will be provided; Artists are responsible to secure items inside their booths. Neither the Board of Directors of BAyC nor the Alma d'arte Charter High School are liable for any damage, theft or loss of Artists' work or display before, during or after Market hours. Artists are encouraged to carry their own insurance.

HOW TO ENTER:

ONLINE: Go to www.bayclc.org and complete the registration document and submit with three sample photos of your work together with the \$35 non-refundable registration fee.

BY MAIL: Go to www.bayclc.org and download the registration document, complete it and mail with three photo samples of your work together with the \$35 non-refundable registration fee and a self-addressed, stamped envelope to: Bellas Artes y Cultura, P.O. Box 16608, Las Cruces, NM 88004.

REGISTRATION DEADLINE: OCTOBER 2, 2023

JURYING PROCESS: Judging will

be conducted by individuals not associated with BAyC. All artwork will be juried based on the following:

Originality, Execution of Design, Technique, Craftsmanship, Creative Use of Materials, and aesthetic qualities.

NOTIFICATION AND CONFIRMATION DATE OF ACCEPTANCE: October 6, 2023 (A

contract and Information Packet will be sent to Artist). The signed contract and booth fee of \$200 is due and payable by: **5:00 pm October 10, 2023.** If accepted into the Market, artists are asked to donate one item for the Silent Auction.

BOOTH FEE: A 10' x 12' space will be allocated for each booth at \$200 per booth. 8' table and 2 chairs will be provided. Booth fees are non-refundable after contract is signed unless under extenuating circumstances as determined by the BAyC Board of Directors.

CONDITIONS:

Only categories listed in application form will be accepted for jurying. Multiple originals, including photographs must be printed on archival quality materials, signed and numbered in limited edition and pulled from the original art work. If accepted into market, marked reproductions such as posters, postcards and printed notecards of original work will be allowed but must represent only 15% of artist's work. Work from molded ceramics, kits, magnets, factory assembly, prefabricated components, clothing such as t-shirts, ARE NOT ALLOWED.
